**Resolution #9.20.18 - Sufficiency of Textbooks or Instructional Materials**

Whereas, the Governing Board of the **Baker Valley Unified School District**, in order to comply with the requirements of Education Code [60119](#), held a public hearing on 9.20.2018 at 5 p.m., which did not take place during or immediately following school hours, and;

Whereas, the Board provided at least 10 days' notice of the public hearing by posting it in at least three public places within the district stating the time, place, and purpose of the hearing, and;

Whereas, the Board encouraged participation by parents/guardians, teachers, members of the community, and bargaining unit leaders in the public hearing, and;

Whereas, information provided at the public hearing detailed the extent to which textbooks and instructional materials were provided to all students, including English learners, in the Baker Valley Unified School District, and;

Whereas, the definition of "sufficient textbooks or instructional materials" means that each student, including English learners, has a textbook or instructional materials, or both, to use in class and to take home, and;

Whereas between the 2008-09 through the 2015-16 fiscal years, the definition of "sufficient textbooks or instructional materials" also means that all students who are enrolled in the same course within the Baker Valley Unified School District, have standards-aligned textbooks or instructional materials from the same adoption cycle, and;

**Finding of Sufficient Instructional Materials**

Whereas, sufficient textbooks and instructional materials were provided to each student, including English learners that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in the following subjects:

**\* Mathematics:** K-6 \* Go Math – Houghton-Mifflin; 7/8 \* Go Math- Houghton-Mifflin; 9-12 \*Math Vision- UOE Project

**\* Science:** K-6 \* Calif Science-Houghton Mifflin; 7/8\* Calif Physical and Life-Holt; 9-12 \* Modern Biology-Holt, Rinehart and Winston; Modern Chemistry- Holt Rinehart; Earth Science- Holt Rinehart and Winston\* **History-social science:** K-6 Calif. History/SS – Houghton Mifflin 7/8 \* E Pluribus Unum The American Pursuit of Liberty, Growth, & Equality 1750-1900-First Choice Educational Publishing; 10-12\* Impact Calif-Social Studies – McGraw Hill Education

**\* English/language arts,** including the English language development component of an adopted program: K-6 Wonders-McGrew-Hill; 7 & 8- Study Sync, McGraw-Hill and English 3D. 9-12 Calif. Collections, Houghton-Mifflin; ERWC – Cal State University

Whereas, sufficient textbooks or instructional materials were provided to each student enrolled in foreign language or health classes, and;

Whereas, laboratory science equipment was available for science laboratory classes offered in grades 9-12, inclusive; Therefore, it is resolved that for the **2018-2019** school year, the Baker Valley Unified School District, has provided each student with sufficient textbooks and instructional materials aligned to the academic content standards and consistent with the cycles and
